



FAQ

1. How do I submit my entry for the awards?

- You can submit your entry through our online submission form. Follow the guidelines provided and fill out the required fields.

2. What are the eligibility criteria for the awards?

- All entrants must be exhibitors at Middle East Energy 2026
- Products/solutions must have been launched within the past 18 months
- Entries must relate to products/solutions being physically displayed at your exhibition stand
- For category-specific criteria, please review the detailed submission guidelines

3. Is there a fee to submit for the awards?

Nominating is completely free.

4. Can I submit multiple entries for different categories?

- Yes, you can submit multiple entries for different award categories. Ensure each submission meets the specific criteria for the chosen category.

5. What is the deadline for submission?

- The deadline for submissions is **16 January 2026, 6:00 PM GST**. Late submissions will not be accepted, so please ensure you submit before the specified date.

6. When will I know if my entry has been shortlisted?

- Shortlisted entrants will be notified by email approximately 6 weeks before the awards ceremony. The shortlist will also be published on the Middle East Energy website.

7. How is the confidentiality of my submission handled?

- All submitted information will be treated as non-confidential unless specifically marked as confidential. Information marked as confidential will only be shared with judges for evaluation purposes. Please note that basic information about shortlisted entries and winners will be used in promotional materials.

8. Who owns the intellectual property rights to my submission?

- You retain ownership of all intellectual property rights in your submitted materials. By entering, you grant Informa Markets permission to use your submission for purposes related to the Awards, including promotion and publicity.

9. How will the judging process be conducted?

- The judging process typically involves a panel of industry experts who will evaluate entries based on predetermined criteria. The winners will be selected based on their performance against these criteria.

10. When will the winners be announced?

- The announcement date for the award winners will be **7 April 2026**. Winners will be notified via email and announced on our website.

11. Can I use the award logo if I win?

- Yes. Winners will receive official award logos that can be used in marketing materials, websites, and product packaging in accordance with the logo usage guidelines that will be provided.

12. Is there an opportunity to provide supplementary materials along with the entry?

- Yes, in some cases, you can submit supplementary materials that support your entry. Please refer to the submission guidelines for details.

13. Can I edit my submission after it has been submitted?

- Yes. You can edit your submission until the **deadline of 16 January 2026, 6:00 PM GST**, after which the system will be locked, and no further changes will be permitted.
